

## **IJDA MEMBERSHIP MEETING**

**I. Call to Order-** Kevin Mann called the meeting to order at 10:30am.

**II. Introductions-** Introductions were made.

**III. Approval of March minutes-** Jim Higdon made a motion to approve the May minutes. Brent Kelley seconded. The motion passed unanimously.

**IV. Treasurer's Report-** Jim Higdon reported that the current checking account balance is \$9,067.03. The current CD balance is \$9,885.52. There are still 20 outstanding registration fees for the 2011 IJDA Summit. Reminder letters/invoices will be sent tomorrow. Jim also reported that the bank which has IJDA accounts has waived the \$5 a month fee now and in the future.

### **V. Committee Reports-**

**1. Membership-** April Dubree reported on behalf of Tracey Agner that the current membership is 110. Memberships are still being received by Indiana professionals applying for the Indiana Youth Careworker Certification.

**2. Regional Trainings-** April Dubree reported that there are 26 people registered for the "Secrets of Supervision" Training to be held on June 15-17 in Allen County. This training allows up to 35 people, so additional slots are still open. The IJDA will reimburse for one room, mileage and per diem.

**3. Summit-** April Dubree reported that many counties attended the 2011 Summit and overall evaluations stated that majority of participants were very pleased with the event. IJDA received great overall scores on sessions and mediocre reviews on hotel food. There were no specific complaints on the process or meal for the 1<sup>st</sup> day lunch. One session that received poor reviews was the Gangs; as the presenter was new and wasn't prepared for the training and was very timid. This will be taken into consideration for next year's event. The "IJDA Night with the Tins Cap" baseball game went well. In addition, the hotel was very nice and the staff were accommodating even when a problem arose. The Summit Planning Committee will be following the July Meeting to debrief.

**4. National Symposium-** The 2011 NPJS Symposium will be held on October 15 – 19, 2011 at the Sheraton - Keystone at the Crossing. The Indiana Registration rate is \$175. There has been an IJDA Scholarship Committee put together and they will meet following today's Membership Meeting to discuss the grant and how many scholarships will be available. NPJS has also discussed offering Indiana a "discount" or "scholarship" in addition to IJDA's scholarships. This will be discussed more at the NPJS Symposium Planning Committee Meeting on June 23, 2011. There will be a 40 Hour Careworker Training available at the 2011 Symposium.

**5. Standards Review-** No representation present.

**VII. Juvenile Mental Health Project-** Michelle Frazier reported 14 current sites are participating. There are additional sites already doing the MAYSI-2 which will work on being able to share data. There has not been a decision yet as to how these facilities will come on board with the project.

April Dubree mentioned the possibility of Dr. Thomas Grisso attending the Symposium to present information on the Indiana Project which was conducted with Vigo, Henry and Dearborn Counties.

**VIII. Detention Discussion-** Kevin Mann announced that Dr. John Newbauer from Allen County will be retiring, but will still be available to do mental health trainings.

Porter County asked how do other facilities get a doctor on staff? Discussion and suggestions included: using local hospital doctors; go through county jail, but may be expensive; find a new doctor willing to help which may build their practice; most facilities have a contract with a current physician which may cost between \$7,000 - \$10,000/year or even \$18,000 depending on the size of the facility; EMT on each shift to allow dispense of medication (some facilities pay for EMT Training depending on cost).

Porter County asked if every facility has a "consent to treat" form and insurance information at intake? Most facilities stated they do. Also signed for medical mental health treatment and signed each time the child is admitted to facility.

**IX. IJJTF report-** No representative present.

**X. ICJI report-** April Dubree reported on behalf of an email sent from Ashley Barnett that ICJI is currently undergoing a program visit with all of our federal grant partners and was unable to attend. Title II grant applications should be available by the end of June. Funding, however, will be very limited and competitive- Indiana took a 24% funding cut from last year. If people have questions about the applications, available funding, etc., they should contact Ashley Barnett at ICJI.

**XI. Youth Law T.E.A.M report-** Michelle Frazier reported that the JJDP A Report had just a few issues, but the state as a whole looks good for the most part.

The IJDA/YLT will request an amendment for the current grant which will include purchasing \$15,000 in NPJS registration instead of the utilizing it for the training library and will also request an amendment for the upcoming grant to use \$15,000 which is allotted towards the NPJS registration to be used for the training library. This would not increase or decrease the training library or the NPJS registrations, but would allow for the training library to be extended to the end of March 2012 instead of ending in June 2011.

Anyone interested in requesting trainings contact April Dubree. The ASIST Training in Porter County at the beginning of June went really well and received great evaluations.
